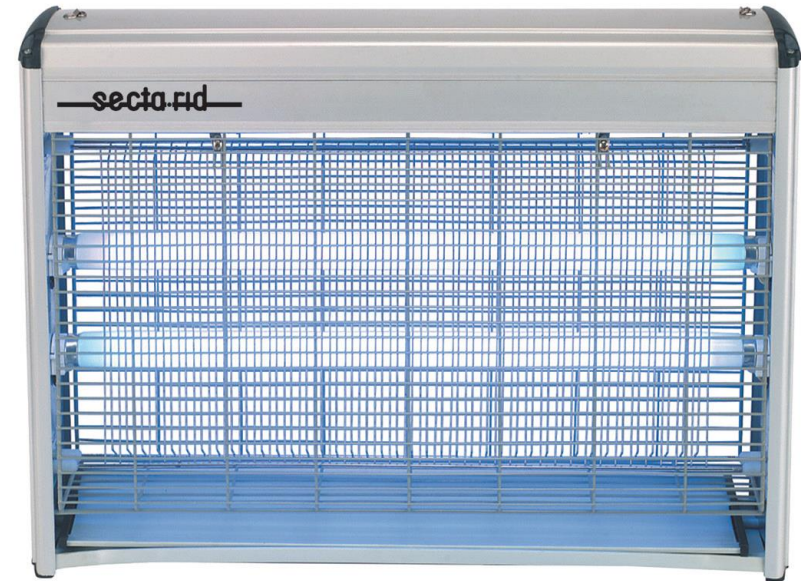

# SECTARID® SR40A COMMERCIAL BUG KILLER

## IMPORTANT SAFETY INSTRUCTIONS:

**Heed Warnings & Retain Instructions:** All warnings on the appliance and in the operating instructions should be adhered to.

**Water & Moisture:** The SectaRid is for INDOOR USE only and not suitable for use in barns, stables, and similar locations. Do not use near water, for example over bath tubs, kitchen sinks or above indoor swimming pools.

**Do Not Modify:** Do not modify, paint, or change the unit in any way.

**Young Children / Infirm Persons:** This appliance is not intended for use by young children or infirm persons unless they have been adequately supervised by a responsible person to ensure that they can use the appliance safely.

**Children:** This appliance is to be kept out of the reach of children and young children should be supervised to ensure that they do not play with the appliance

**Flammable Vapors:** This appliance is not to be used in locations where flammable vapor or explosive dust is likely to exist

**Heat:** The appliance should be situated away from heat sources such as radiators, stoves and other appliances that produce heat.


**Power Source:** The appliance should be powered only as described in these instructions or as marked on the appliance.

**Cleaning:** The appliance should be cleaned only as recommended in these instructions and in accordance with the water and moisture warning stated in this manual

**Liquid Entry:** Do not submerge the main body of the SectaRid Commercial Bug Zapper in water

**Object Entry:** Do not place any object through any of the openings in the SectaRid Bug Zapper

**Extension Cord:** Carry out a physical safety check of extension cord before use. Check for cuts or damage, kinks / twisting, exposed wires, damaged plugs (bent or loose pins). Avoid improper use of extension cords and keep them away from moisture

**Danger:** high voltage 

**Damage Requiring Service:** Appliance should be serviced by a qualified Service Technician when:

- i. Heavy objects have fallen on the appliance
- ii. The appliance has been dropped or the body of the SectaRid has been damaged
- iii. The appliance does not appear to operate normally or exhibits a change in performance
- iv. Supply cord is damaged

**Service:** The user should not attempt to service the appliance beyond that described in these operating instructions. All other servicing should be referred to a qualified Service Technician or returned to The Kelly Company Pty Ltd

## WELCOME

Thank you for purchasing the SectaRid® Commercial Bug Zapper Model SR40A. This manual will provide you with directions for the safe and efficient operation of your SectaRid® Commercial Bug Zapper. Please read the manual carefully.

**Important:** This appliance is not intended for use by persons (including children) with reduced physical, sensory, or mental capabilities, or lack of experience and knowledge unless they have been given supervision or instructions concerning the use of the appliance by a person responsible for their safety. Children should be supervised so that they do not play with the appliance.

The outer protective screen of the SR40A has been designed to prevent fingers or foreign objects from contacting the charged killing grid.

## OPERATION & MOUNTING:

To achieve maximum performance from your SectaRid® Commercial Bug Zapper please review and observe the following recommendations:

- i. Light sensitive flying insects are attracted to the black light UV lamp and when they encounter the electrically charged grid surrounding the lamp they are instantly killed and drop into the removable catch tray
- ii. The SectaRid® Commercial Bug Zapper SR40A is designed for areas up to 120 square metres. For larger areas, multiple units should be used
- iii. The SectaRid® Commercial Bug should be mounted a minimum of 1.7 metres, from the base of the unit to floor level using the 2 hanging rings fitted to the top. Make sure the hanging rings are securely attached to the hanging device. Alternatively, it may be wall mounted using 2 screws (not provided) positioned to align with the mounting holes located in the back of the bug zapper
- iv. If a power extension lead is used it **MUST** be suitable for the intended use. Keep the extension lead dry and off the floor; avoid heat, oil and sharp edges.

**⚠ WARNING** SectaRid® Commercial Bug Zapper SR40A is designed for INDOORS USE ONLY, do not use in barns, stables or similar locations. Do not use outdoors

## UV BLACK LIGHT LAMPS:

The UV Black Light Lamp used in SectaRid® Commercial Bug Zappers are long wave and therefore safe. The output / intensity of the lamp in the invisible ultraviolet frequency range reduce with use. For maximum attraction of flying insects replace the lamp every 12 months.

**Precautions to be taken when replacing lamps and starters**, if applicable. Risk of electric shock, disconnect power before installation, don't switch on power until installations are completed

## SERVICE WARNINGS:

The user must not attempt to service the SectaRid® Commercial Bug Zapper Model SR40A beyond what is described in the section below. All other servicing should be carried out by a qualified electrician or returned to the Service Department at The Kelly Company Pty Ltd at the address shown on the front cover of this Manual.

The return freight / postage of SectaRid® Commercial Bug Zapper Model SR40A during or outside of the warranty period is to be paid by the purchaser. Ensure that the SectaRid® Commercial Bug Zapper Model SR40A is well packed to avoid transport damage as this is not covered under the warranty. Please include written details of the product failure to minimise time and cost of repair.

## ROUTINE MAINTENANCE:

Ensure that the SectaRid® Commercial Bug Zapper Model SR40A is disconnected from its power source before performing any type of maintenance

1. As Required: Dead insects drop into the removable catch tray located directly under the killing grid. Remove the tray by sliding it in an outwards direction, dispose of the dead insects and replace tray.
2. Annually or As Required: Clean the killing grid to maintain maximum performance. In areas of heavy infestations of flying insects grid cleaning may be required monthly or weekly. Use an air blower or brush to dislodge insects trapped on the killing grid. **Do not** remove the front grille of the SectaRid® Commercial Bug Zapper Model SR40A to clean killing grid.
3. Annually: Replace the Black Light UV Lamp annually to ensure maximum output in the invisible ultraviolet frequency range (see page 3 of this Manual). Replacement lamps are available through your nearest stockist of SectaRid® Commercial Bug Zapper Model SR40A. Lamps should be replaced by a qualified electrician or authorised service agent

## WARRANTY:

Congratulations on purchasing the SectaRid® bug zapper, a quality appliance from The Kelly Company. Please read the following warranty information and complete the purchase date and retailer / supplier information as this will be needed when making a warranty claim.

Our goods come with guarantees that cannot be excluded under the Australian Consumer Law. You are entitled to a replacement or refund for a major failure and compensation for any other reasonably foreseeable loss or damage. You are also entitled to have the goods repaired or replaced if the goods fail to be of acceptable quality and the failure does not amount to a major failure. The product is warranted for 1 year from date of original purchase.
