OPERATION & MOUNTING:

To achieve maximum performance from your Sectrarid FlyTrap® FT-40 please review and observe the following recommendations:

- Light sensitive flying insects are attracted to the black light UV lamp and trapped on the adhesive board positioned in the removable plastic support tray
- ii. The Sectrarid FlyTrap® FT-40 is designed for areas up to 100 square metres. For larger areas multiple units should be used
- iii. The Sectrarid FlyTrap® FT-40 should be mounted a minimum of 1.7 to 2.0 metres, from the base of the unit to floor level
- For ceiling / suspended mounting use the 'S' hooks and wire provided are connected to the suspension holes/lugs located at each end/top of the FT-40.

For wall mounting use the bracket provided; firstly use the template, which is a part of the carton, to achieve correct positioning of wall penetrations relative to the holes in the mounting bracket. Separate screws and plugs are provided for mounting to concrete walls or masonry walls

v. If a power extension lead is used it **MUST** be suitable for the intended use. Keep the extension lead dry and off the floor; avoid heat, oil and sharp edges.

Utilising adhesive board technology FlyTrap has been specifically designed for use in food preparation areas where the use of conventional 'zapping' units is undesirable. FlyTrap® can be free standing, wall mounted or ceiling suspended.

INSTALLATION

FlyTrap® requires certain conditions to ensure the effective control of flying insects in your premises:

- 1. It must be correctly sited.
- 2. It must be in operation 24 hours a day.
- 3. Tubes must be replaced every 12 months.
- The SectaTac Glue Board must be replaced every 4 weeks.

POWER REQUIREMENTS

FlyTrap® is designed to operate from a 240 Volt power outlet. The unit must be connected to an earthed electrical power supply. The mains lead supplied with FlyTrap® is already fitted with a molded SAA Approved plug.

SLIDE INTO POSITION

SITING

FlyTrap® should be positioned at least two metres above floor level preferably in the darkest place within the area to be protected, away from windows and skylights thus avoiding any competition with natural daylight or sunlight.

Larger areas may require two or more units and positioning requires careful consideration to ensure maximum protection. Each unit should be centrally positioned to achieve maximum coverage and instructions given in the Installation Section should be followed.


If FlyTrap® is to be wall mounted the template included as part of the carton must be used in order to achieve correct alignment of the unit to the mounting bracket and wall.

Refer to 3 Step Instructions to the left of the diagram for the procedure for fitting and removing FlyTrap® Adhesive Board Replacement and Lamp to and from FlyTrap®.

Before servicing FlyTrap® always ensure that the unit is disconnected from the mains power supply.

- Replace the FlyTrap® Glue Board Cat.
 No. 71273 every 4 weeks or more frequently if needed.
 - Replace the Ultra Violet LampsCat No. 71108 every 12 months.
