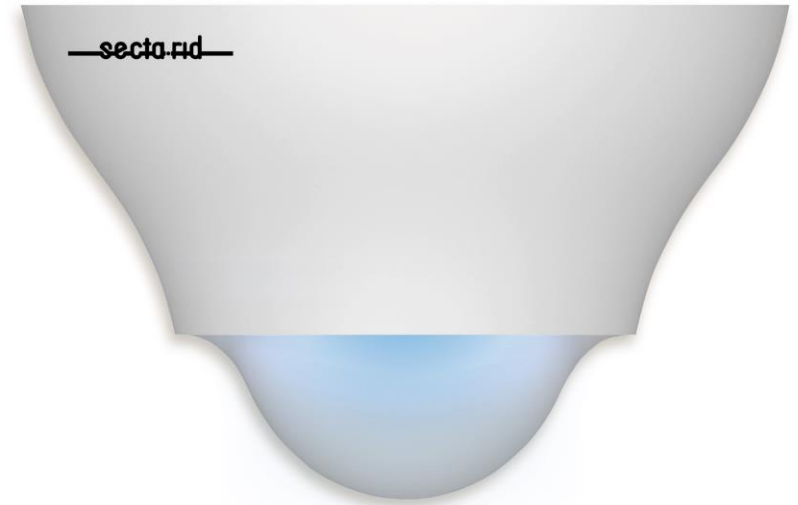

IMPORTANT SAFETY INFORMATION

Read Instructions before operating.

Indoor Use Only: The SR-20 DECOR™ FLY TRAP is for INDOOR USE only and is not to be exposed to moisture or rain.

All warnings on the appliance and in the operating instructions should be adhered to and all operating and user instruction should be followed.

This appliance is not intended for use by persons, including children, with reduced physical, sensory or mental capabilities or lack of experience and knowledge unless they have been given supervision or instruction concerning the use of the appliance by a person responsible for their safety. Children should be supervised to ensure they do not play with the appliance.

Water and Moisture: The appliance should not be used near water for example, near a bathtub, washbowl, kitchen sink, washing machine, or near a swimming pool.

Ventilation: The appliance should be situated so that its location or position does not interfere with its proper ventilation. Thank you for purchasing the Sectrarid FlyTrap SR-20 Decor™. This manual will provide you with directions for the safe and efficient operation of your SR-20 Design. Please read the manual carefully and keep it in a safe place for future reference. Failure to operate the SR-20 Decor™ in accordance with the instructions in this manual may cause damage to the unit.

MOUNTING:

To achieve maximum performance from your Sectrarid FlyTrap SR-20 Decor™ please review and observe the following recommendations:

- i. Light sensitive flying insects are attracted to the black light UV lamp and trapped on the adhesive board
- ii. The Sectrarid FlyTrap SR-20 Decor™ is designed for areas up to 40 square metres. For larger areas multiple units should be used
- iii. The Sectrarid FlyTrap SR-20 Decor™ may be conveniently wall mounted a minimum of 1.7 to 2.0 metres, from the base of the unit to floor level
- iv. If a power extension lead is used it **MUST** be suitable for the intended use. Keep the extension lead dry and off the floor; avoid heat, oil and sharp edges.

UV BLACK LIGHT LAMPS:

The Energy Saving UV Black Light Lamp Cat No 71469 used in your Sectrarid FlyTrap SR-20 Decor™ is long wave and therefore safe. The output / intensity of the lamp in the invisible ultraviolet frequency range reduce with use. For maximum attraction of flying insects replace the lamp every 12 months.

INSTALLATION & OPERATION

The Sectarid FlyTrap SR-20 Decor™ utilizes black light ultraviolet lamp and the commercially proven adhesive entrapment technology to effectively attract, capture and kill flying insects with no zap, or chemicals. The entrapped flying insects become dehydrated and die.

Adhesive Entrapment Media (Glue Board)

The Adhesive Entrapment Media (Glue Board Mat) is manufactured from a specially developed glue formula specifically designed for the entrapment of flying insects. It retains its adhesive qualities for up to 6 weeks and is changed simply and hygienically in a matter of seconds by sliding it in and out of the appliance

1. **Replacement:** adhesive entrapment mat should be replaced every 6 weeks, or sooner should it become overloaded with captured / dead insects
2. **Installation:** To install the mat do the following:
 - i. Write the installation and replacement date on the reverse side of the mat.
 - ii. Peel off the 'release paper' to expose the chartreuse (yellow) adhesive surface.
 - iii. Holding the mat by the non-tacky edge, and with the adhesive surface facing towards the front of the appliance, slowly slide it into the slots at the rear of the Decor™ taking care to not to touch the lamp with the adhesive surface
 - iv. If the mat comes into contact with the black light UV lamp it will stick to it. Simply pull the mat up out of the SR-20 Decor™ and repeat iii.
 - v. Wall mount the SR-20 Decor™ a minimum of 1.7 to 2.0 metres, from the base of the unit to floor level
 - vi. Your SR-20 Decor™ is now ready for use.
3. **Removal:** To remove the adhesive entrapment mat do the following:
 - i. Turn off the power to the SR-20 Decor™
 - ii. Holding the mat by the non-tacky edge, slide it out taking care not to allow the adhesive surface of the mat to contact the black light UV lamp.
 - iii. Reinstall the adhesive entrapment mat

NOTE: Never cover the top of the SR-20 Decor™ as this will prevent flies and other flying insects from entering the entrapment chamber
